

DROMNIBUS SP. Z O.O. PRIVACY POLICY AND PERSONAL DATA PROTECTION

By using our services, you entrust us with your personal data. DROMNIBUS Sp. z o.o. acknowledges your right for privacy and safety of the data you entrust to us. In this Policy, you will find our approach to the collection, processing and use of user data.

I. The administrator of your personal data collected via the Website www.dromnibus.com (hereinafter referred to as the Website) is DROMNIBUS Sp. z o.o., located in Kraków (31-124), Ul. Dolnych Młynów 3/1, entered in the Register of Entrepreneurs of the National Court Register by the District Court in Kraków – Śródmieście in Kraków, XI Commercial Division of the National Court Register under KRS number: 0000472501, NIP (TIN): 6762466869, REGON: 122919579, with share capital in the amount of PLN 195,550.00, (hereinafter referred to as We or the Company).

II. We wish to inform you that in order to use the services of the Company, you provide the required data. The provision of this data is completely voluntary, but necessary for the Company to provide our services. As a user, you provide data such as your name, address, telephone number, e-mail address, and your login and password, which are necessary for authorization (logging in) and full access to the Website. Additional details, such as your home address or TIN may be needed to issue an invoice.

III. The Company processes the data you provide to the extent necessary to provide the service and to enable the provision of services offered through the Website, as well as for marketing, statistical, and market research purposes.

IV. Your personal data included in registration forms, as well as other data collected automatically, are processed in accordance with the provisions concerning personal data protection, in particular, in accordance with the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation), hereinafter referred to as RODO.

V. We reserve the right to disclose selected user data to the competent authorities or third parties who submit a request for such data, in accordance with an appropriate legal basis and the applicable law. Except for the cases indicated in the preceding sentence, your data will not be disclosed to any third party without your consent.

VI. In accordance with RODO, we inform you that you have the right to:

- access your data;
- request to correct or add to your data;
- request to limit the processing of your data;
- request to cease the processing of your data and to delete your data;
- file objections.

You can exercise your rights using the e-mail address provided on our Website.

VII. We wish to inform you that upon connecting to the Website, information about your number (including IP) and the type of terminal device you use to connect to the Website appears in the Website's system logs. Consequently, we will also process, in accordance with the law, the information regarding the number (including IP) and type of your terminal device and the time you connected to the Website, as well as other operational data regarding your activity on the Website. Non-personal data is collected automatically for administrative and technical purposes and are used to create collective statistics about the traffic on the Website, Users, and their behavior.

VIII. The Website uses cookie files (text files saved and stored on the User's computer disk to maintain your navigation parameters and login status). You can disable cookies at any time in your web browser. However, this may cause certain difficulties in using the Website.

IX. We declare that we will take care to provide you with a high level of security in using the Website and the protection of personal data. We also declare that the Company has appointed a Data Protection Officer. Any events impacting the security of information transfer, including the suspicion of sharing files that contain viruses and other files of a similar nature, should be reported to the e-mail address kontakt@dromnibus.com.

X. We declare that modern technologies for securing content, accessing content and accessing personal data that protect the Website are used to ensure the highest possible level of security. The Website uses a secure SSL Certificate, as well an algorithm with a 256-bit encryption key that protects the Website, encrypts data, ensures the confidentiality of data transmitted electronically, and prevents the hijacking of data via a secure site.
